To help members plan ahead to participate in our annual conference, the National Association for Family Child Care (NAFCC) has designed a Conference Layaway Plan. To take advantage of this opportunity, you **must be an NAFCC member** and must pay your balance in full by **May 15, 2009**.

The **Layaway Plan** includes your Conference Registration and hotel room for three nights, Thursday June 25 through Saturday June 27, with checkout Sunday, June 28. Additional nights may be added between June 20 and June 24 at the conference rate.

The Layaway plan includes a minimum of **eight payments, starting October 29, 2008**. The final payment must be postmarked no later than **May 15, 2009**. The first payment must be included with the application. Any balance not paid in full by May 15, 2009 will be returned, minus a processing fee of \$100.00. All other conference registration cancellation fees apply.

You may make layaway payments by check, money order or credit card. If using a credit card as your payment method, please choose the payment date you prefer and the payment amount. Checks or money orders should be mailed directly to NAFCC at 1743 Alexander Street, Salt Lake City, Utah 84119.
